General Recommendations

EDTA CALCIUM is intended for the prevention and/or correction of Calcium deficiencies in all crops when determined by a soil test or plant tissue analysis. Because EDTA CALCIUM is fully chelated it is designed for mixing with liquid NPK starter fertilizers including those made with orthophosphate and/or containing pesticides.

Row or Band Application

Apply 2.5-5 pounds (1-2 quarts) EDTA CALCIUM per acre, just before or at planting time.

Broadcast Application

Apply 5-10 pounds (2-4 quarts) EDTA CALCIUM per acre, just before planting and work into the top 3-5 inches of soil.

Note: For foliar application, EDTA CALCIUM may be used at the rate of 2-4 pounds (1.5-3 pints) per acre with a minimum of 20 gallons of water. Or use BRANDT FOLI-CAL for foliar applications.

Optimum rate of application will vary between fields, depending on soil pH and organic matter content. For best results, follow soil test or plant analysis recommendation.

Put 1/3 of water in tank. Add correct amount of EDTA CALCIUM. Fill tank with balance of fertilizer or water. Add other chemicals, if any. Agitate adequately to mix.

Caution: Check compatibility by utilizing a jar test before mixing.
